From 1978 until 1980, he fulfilled his obligatory military service in the Hellenic Air Force. In 1982, he completed postgraduate studies in European law at the Université libre de Bruxelles. During his studies, he served as vice-president of the Thessaloniki law students' union as well as president of the Greek students' association of Belgium. In 1986, Andreas Loverdos completed his PhD at the Aristotle University of Thessaloniki with the thesis Terrorism and Political Crime: Study from the Perspective of Law. In 1991, he undertook research at the London School of Economicson the function of government and in 1996 he researched the function of democratic constitutions at Boston University. He was a Lecturer in 1986, an Assistant Professor in 1992 and an Associate Professor in Public Law, Pantion Univercity of Athens in 1997. He is an author of numerous articles in legal research journals. He was a leading cadre of the Panhellenic Socialist Movement and he was first elected to the Hellenic Parliament in the 2000 legislative election. From 23 January 2002 until 10 March 2004 he served as Deputy Minister for Foreign Affairs. In October 2009, he was appointed Minister for Labour and Social Security. In September 2010, he was appointed Minister for Health and Social Solidarity. He held this post until 17 May 2012, when the coalition government of Lucas Papademos was replaced by the caretaker government of Panagiotis Pikrammenos. On December 3 2012, he announced the launch of a new political movement, the Radical Movement of Social Democratic Alliance (RIKSSY). and was subsequently expelled from the PASOK parliamentary

group. A new political party, the Agreement for the New Greece, was formed by Loverdos and other members of RIKSSY on 15 April 2013. Andreas Loverdos returned to the government as Minister for Education and Religious Affairs on 10 June 2014. and to the PASOK parliamentary group on 22 August 2014. ### Panagiotis Kouroumplis f. Minister of Health Member of Parliament SYRIZA

Panagiotis Kouroumplis is a lawyer, Dr. of Social Sciences and an MP for the 2nd Athens District. He has been elected thrice in Aetoloakarnania District with PASOK (1996, 2000 and 2009) and four times in the 2nd Athens District with SYRIZA (May and June 2012, January and September 2015). In 1993 by decision of Andreas Papandreou he was appointed General Secretary for Welfare at the Ministry of Health. Between 2015 and 2018 he served successively as Minister of Health, Interior & Administrative Reconstruction and Maritime Affairs & Insular Policy in governments under Alexis Tsipras. He is a descendant of refugees from Pontus who settled in Aetoloakarnania, where he was born in 1951. At age 10 he lost his eyesight entirely following the explosion of a hand grenade from WWII. Between 1976 and 1981 he was one of the pioneers in the struggle of the blind for the enshrinement of their rights to education and employment, during which he was prosecuted several times. Serving in the cabinets of all Ministers of Health during the period 1981-1989, he contributed to the drafting of legislation that set the foundations for the welfare state in Greece. In 1990 his efforts of the previous ten years resulted in the establishment of the National Confederation of Disabled People, through which the Greek disabled movement was finally unified. He served as its first president until 1993. As General Secretary for Welfare between 1993 and 1996 he focused on the protection of children, the elderly, large families and the disabled. During his tenure as Minister of Health he enacted measures for the health cover of uninsured citizens and vulnerable groups and abolished the 5 euro fee for citizens' access to the National Health Service. In Councils of EU Health Ministers and at the WHO General Assembly he was among the first to raise the prospect of common negotiations of EU memberstates with big pharmaceutical companies for the procurement of expensive innovative medicines. As Minister of Interior & Administrative Reconstruction he legislated proportional electoral representation and the right to vote from age 17. In his capacity as Minister of Maritime Affairs & Insular Policy he legislated the admission to the Hellenic Coast Guard through standardized examination for the first time, supported Greek shipping in international fora and undertook initiatives to upgrade Greek maritime education. Panagiotis Kouroumplis has been honored numerous times for his achievements in the social realm including by the Academy of Athens. Citing his own example, he encourages the young to reject all forms of resignation and fight to fulfill their dreams. He is married and has two children.
