Thomas Bartzanas is Professor, Vice Rector for Research, Finance and Development, Professor and Director of the Lab of Farm Structures at the Agricultural University of Athens (AUA) and Chairman of the Board at SmartAgroHub S.E, a spin-off of AUA. He is an agricultural engineer, with a PhD in agricultural engineering systems and process at the University of Thessaly and the Bioclimatology station of INRA in France and a postdoctoral fellowship at the University of Aarhus in Denmark (Department of Engineering). His research interests focus on the development, evaluation and application of new techniques and technologies in controlled environment production systems (greenhouses, vertical farming systems, hydroponic systems, livestock buildings), the sustainable and smart use of natural resources in the agrifood sector and the assessment of the environmental impact (environmental footprint) in the agrifood sector using the life cycle analysis. He has participated as a Coordinator and/or Researcher in 50 national and European research programs and has more than 350 publications in international journals and conference proceedings (h-index 33/5100 citations). Thomas is Associate Editor in Biosystems Engineering and member of the EurAgEng, vicechair in the Structures & Environment Committee of CIGR and member of the Scientific Council of the European Union, in the Directorate for Research and Innovation for open access to research results in the field of Agricultural Sciences.


Alexander Betts is Professor of Forced Migration and International Affairs, and Senior Fellow in Politics at Brasenose College, at the University of Oxford. His research focuses on refugees' access to socio-economic opportunities, and he has undertaken research across Africa and Europe. He has published 12 books, around 100 scholarly publications, and won several academic prizes, including from the International Studies Association and American Political Science Association for his scholarship, and the ESRC's Outstanding International Impact Prize. He has been named by Foreign Policy magazine as one of the world's top-100 global thinkers, by the World Economic Forum as a Young Global Leader, by Friends of Europe as a European Young Leader under-40, and by Thinkers50 on their radar list of emerging business influencers. He has written for the New York Times, the Washington Post, and the Guardian, and his TED talks have been viewed by over 3 million people. He has previously served as the Director the Refugee Studies Centre, Associate Head of the Social Sciences Division, and is co-founder of the Oxford SDG Impact Lab and the Refugee-Led Research Hub in Nairobi. He was previously the World Masters and European Universities debating champion. In his spare time, he coaches an Oxford City under-9s team and is a long-distance runner who has completed the 6 Abbott World Marathon Majors. 

Her extensive publications include five monographs: Pollution from offshore installations (Martinus Nijhoff, 1995 -Guggenheim Prize), State Immunity and the Rule of Law (Ant. N. Sakkoulas, 2001), Functional jurisdiction in the Law of the Sea (Martinus Nijhoff, 2007), Energy installations in the sea (Nomiki Bibliothiki, 2016) and Energy at Sea (Edward Elgar, 2024). She has edited eight collective works, contributed many papers to collective volumes, and published numerous articles in Greek, English, French and Italian. She is fluent in Spanish and has a basic knowledge of German. She is one of the editors-in-chief of the Yearbook of International Environmental Law (OUP). President of the International Law Association - the Greek branch of the ILA, and Vice President of the Hellenic Society of International Law & International Relations. #### **Dr. Stamatios Krimigis, President, Academy of Athens**

Dr. Stamatios (Tom) Krimigis is Emeritus Head of the Space Exploration Sector at the Johns Hopkins Applied Physics Laboratory (APL), President of the Academy of Athens where he occupies the Chair of Science of Space and Applications, has built instruments that have flown to all 9 classical planets beginning with Mariner 4 to Mars in 1965 and ending with New Horizons to Pluto in 2015; also the Moon, the asteroid Eros, and the Parker Solar Probe to the Sun in 2018, and is Principal Investigator on NASA's Voyager 1 and 2 Interstellar Mission to the outer planets and the Galaxy. He has published over 640 papers in peer-reviewed journals and books with over 27,000 citations and h-index of 87. He is a three-time recipient (1981, 1986, 2014) of NASA's Exceptional Scientific Achievement Medal. In 1999 the International Astronomical Union named asteroid 1979 UH as 8323 Krimigis. He is a Fellow of the American Physical Society (APS), the American Geophysical Union (AGU), the American Association for the Advancement of Science (AAAS) and the American Institute of Aeronautics and Astronautics (AIAA). Other awards include the Council of European Aerospace Societies CEAS Gold Medal in 2011, the European Geophysical Union Jean Dominique Cassini Medal (2014), the AIAA Van Allen Space Environments Award (2014).
